## WHAT'S REQUIRED TO BE A CAREGIVER IN YOUR STATE?

**Initial Training:** 0 hours

**Ongoing Training:** 0 hours

Currently, the South Carolina Department of Health has no training requirements for caregivers working in senior care. However, to ensure your caregivers provide superior client care in accordance with industry standards, **In the Know recommends caregiver certification through an eight-hour training program** in basic caregiving skills.

# YOUR HOME HEALTH AIDE TRAINING REGULATIONS

## WHAT'S REQUIRED TO BE A HOME HEALTH AIDE IN YOUR STATE?

To care for Medicare or Medicaid clients, all home health aides in South Carolina must complete training according to federal regulations.

**Initial Training:** A minimum of 75 hours, including 16 clinical hours.

**Certification:** Must pass an exam to become a home health aide at a certified home health agency.

**Ongoing Training:** 12 hours/year if working for a Medicare/Medicaid certified home health agency; annual competency testing/evaluation on 13 key subject areas. (See Medicare/Medicaid requirements and Joint Commission recommendations later in this booklet.)

## WHAT'S REQUIRED TO BE A CERTIFIED NURSING ASSISTANT (CNA) IN YOUR STATE?

All nursing assistants must be certified in order to work.

**Initial Training:** A minimum of 100 hours, including 40 clinical hours.

**Ongoing Training:** 12 hours/year if working for a Medicare/Medicaid certified home health agency; annual competency testing/evaluation on 13 key subject areas. (See Medicare/Medicaid requirements and Joint Commission recommendations later in this booklet.)

# FEDERAL TRAINING REGULATIONS

## FEDERAL REQUIREMENTS

All agencies that receive federal funds from Medicare or Medicaid must deliver 12 hours/year annual competency testing/evaluation on 13 key subject areas, as follows:

1. Communications skills
2. Observation, reporting and documentation of patient status and the care or service furnished
3. Reading and recording temperature, pulse, and respiration
4. Basic infection control procedures
5. Basic elements of body functioning and changes in body function that must be reported to an aide's supervisor
6. Maintenance of a clean, safe, and healthy environment
7. Recognizing emergencies and knowledge of emergency procedures
8. The physical, emotional, and developmental needs of and ways to work with the populations served by the Home Health Agency, including respect for the patient, his or her privacy and his or her property
9. Appropriate and safe techniques in personal hygiene and grooming that include:
  - Bath (bed, sponge, tub or shower bath)
  - Shampoo (sink, tub, or bed)
  - Nail and skin care
  - Oral hygiene
  - Toileting and elimination
10. Safe transfer techniques and ambulation
11. Normal range of motion and positioning
12. Adequate nutrition and fluid intake
13. Any other task that the Home Health Agency may choose to have the home health aide perform
